The insurance coverage includes the liability of the INSURED for damages, caused to consumers of organized group and individual travels with a total price (organized travels) as a consequence of non settled payments on behalf of the INSURED towards his counteragents or suppliers, including the case of its insolvency as follows:<ol style="list-style-type: none">1.1. Reimbursement of amounts paid by the contract consumer for organized travel before commencement of the travel;1.2. Payment of difference in the cases when during the travel only part of the services, agreed in the contract, have been provided;1.3. Payment of expenses related to the return of the customer to the point of origin of the travel;1.4. Indemnity of expenses for claim settlement, made with the explicit agreement of the INSURED2. The present insurance covers only damages in result of the arisen risks, which are described in Chapter I, p.2 of the present Special Conditions, suffered by the consumer(s) of organized travels in the whole world.		

	3. When limitation of liability of the tour operator is provided in the contract of organized tourist travel, the liability of the INSURED for 1 consumer is limited to that amount according to Chapter I, p. 2.1, 2.2 and 2.3, but not exceeding the amount of liability of the INSURED.
